Energy Audit Report from Dan Olmsted

Dan Olmsted summed up the report he had done on behalf of Earthcare Partners re energy consumption & greenhouse gases. He made an inventory re building, heating equipment, and possible areas for improvement – places to reduce energy consumption. Dan said that the church maintenance workers are doing a great job keeping costs down given the size of the building but there are some improvements which could be made. Changing lights to LEDs would pay back the quickest. These are being changed to LEDs when they need replacing. Boilers are the cheapest, most efficient way to heat a building this size, but our boilers are nearing the end of their lives. He estimates they are 40 – 60% efficient; the new standard would be 85%. It could cost \$600- 800,000 to replace both boilers and the ventilator. Boiler replacement might trigger fire code upgrades and the need for sprinklers, so It would be good to have \$1,000,000 in place. There might be federal grants available to go to high efficiency. Dan could get price estimates if we want and suggests that total costs could be as high as 1 million dollars. Action items: Dan Olmsted & the Stewardship committee will look into grants for energy efficient upgrades-possible federal grants and or as a heritage building. Dan will get a ballpark estimate of the cost to replace the boilers.
